It was approved by all voting board members with the understanding moving forward wage increases would remain in 0-3% range now that the classroom aides' wages are more comparable with industry standards.

- Arnold researched and presented the average teacher salaries for Charlevoix Public Schools and contacted Mason & Kammerman about opportunities to increase Varagas' wage. Arnold will share this information with the board as it becomes available.
