- IV. Directress Report: Molly Arnold, Directress
- Arnold gave an overview of the staff's visit to Leelanau Montessori Public School System from 11/5/14. The Leelanau Montessori Public School System offers a toddler program through sixth grade and is publicly funded through the State of Michigan. LMPSA is housed on the Suttons Bay Public School's Campus and the Head of School, Connie Laufersky, offered her assistance with Charlevoix Children's House and our relations with Charlevoix's Public School System.

- Arnold addressed that Fall Clean-Up was completed by KP and Molly Arnold expressed the need of the flower beds needing more attention. KP said that the work would be completed by first snow fall, so this time is upon us.
- Arnold again addressed the need for new building doors and plans to get pricing information from Home Depot after attaining measurements. Bogart offered his help in this matter.

### Fundraising Committee: Chair: Perry Hodgson

- FRIGHT NIGHT: Hodgson is working on the final, exact numbers, but Fright Night was a great success!
- Ticket Sales: 111 tickets were sold and stubs collected during the event, yielding a revenue of \$4,000.00.
- Silent and Live Auction: Over 200 items were collected for a retail value of \$16,000.00 and sold for \$8,000.00. There are a few auction items that did not receive bids that may be opened to parents to purchase.
- Hodgson offered to Chair Fright Night 2015, marking the 10<sup>th</sup> anniversary of the event. Hodgson is hoping to coordinate and accommodate with Charlevoix Public School, so there is no conflict with the Elementary School's Halloween Party. Hodgson is hoping to secure Friday, October 30, 2015 for Fright Night and looking into the possible deposit for this date from 2013.
- Hodgson addressed the need to book Scott Mackenzie in advance to emcee for next year's event
- Daniela Rozendo received a recent \$1,000.00 donation from an anonymous donor for Fright Night that could be interested in future benevolence, which led to the discussion of creating a Wish List for CCH and potential donors. Wish List ideas brainstormed tonight included replacing materials, further insulation of the building, adult folding chairs and expanding the program to 3<sup>rd</sup> grade. Hodgson volunteered to create a Wish List to be posted at CCH for parents to brainstorm ideas as well.
